## Am I Eligible?

All registered full-time undergraduate students in an on-campus program are required to have health insurance coverage, either through this Student Health Insurance Plan or through another individual or family plan. All registered International graduate students in an on-campus program (excludes executives) are required to have health insurance coverage.

All International Graduate Students who enroll in the two- or three-month sessions are not eligible to waive and are automatically enrolled in the insurance for the same dates as the Session. This Excludes Executive Programs.

## How Do I Confirm Enrollment and/or Waive?

International graduate students are not eligible to waive the insurance and will automatically be enrolled in the student health insurance for the same dates as the Session they attend.

All registered full-time undergraduate students in an on-campus program will need to confirm enrollment or waive the New England College Student Health Insurance Plan (SHIP) and will be required go to: <https://www.studentinsurance.com/Client/1517> by the deadline to make their selection. Students who would like to waive the New England College SHIP need to have their current insurance information available to provide proof of comparable insurance coverage. **The fall waiver deadline is September 6, 2021, or the spring (new students) waiver deadline is February 7, 2022.**

**Pre-Certification**

Pre-Certification is required for inpatient hospital, surgery, and selected outpatient services. Pre-Certification is not required for an Emergency Medical Condition or for a Life-Threatening Condition or Urgent Care or Hospital Confinement for the initial 48/96 hours of maternity care. Additionally, no authorization requirement will apply to obstetrical or gynecological care provided by In-Network Providers.

**Exclusions and Limitations**

**Exclusion Disclaimer:** Any exclusion in conflict with the Patient Protection and Affordable Care Act or any state-imposed requirements will be administered to comply with the requirements of the federal or state guideline, whichever is more favorable to You.

The Certificate does not cover loss nor provide benefits for any of the following, except as otherwise provided by the benefits of the Certificate and as shown in the Schedule of Benefits.

1. **International Students Only** - Eligible expenses within Your Home Country or country of origin that would be payable or medical Treatment that is available under any governmental or national health plan for which You could be eligible.
2. Treatment, service or supply which is not Medically Necessary for the diagnosis, care or treatment of the Sickness or Injury involved. This applies even if they are prescribed, recommended, or approved by Your attending Physician or dentist.
3. Medical services rendered by a provider employed for or contracted with the Policyholder, including team physicians or trainers, except as specifically provided in the Schedule of Benefits.
4. Professional services rendered by an Immediate Family Member or anyone who lives with You.
5. Routine foot care, including the paring or removing of corns and calluses, or trimming of nails, unless these services are determined to be Medically Necessary because of Injury, infection, or disease.
6. Infertility treatment (male or female)-this includes but is not limited to:
  - Procreative counseling;

- Premarital examinations;
  - Genetic counseling and genetic testing;
  - Impotence, organic or otherwise;
  - Costs for an ovum donor or donor sperm;
