## General Information

### Am I Eligible

All registered full-time students taking 9 or more credits are required to have health insurance coverage, either through Saint Joseph's College SHIP or through another individual family plan. Students are automatically billed by the College. The charge will be removed once an approved waiver is issued.

### Dependents

Dependents are not eligible.

### How Do I Waive/Enroll?

#### To Waive:

- All registered full-time students taking 9 or more credit hours will need to take action every school year to either Enroll or Waive the Saint Joseph's College Student Health Insurance Plan prior to arriving on campus.
- To waive or enroll, go to: <https://www.studentinsurance.com/Client/1526>. Review the information there and decide if you should Enroll or request to Waive the Saint Joseph's College Student Health Insurance Plan (SHIP)
- Next click the button to Enroll or Waive. Students will be prompted to log into their existing Wellfleet account. If you do not have a Wellfleet account, select, "Create an Account" and proceed.
- If you are requesting to Waive the SJC SHIP, you are required to upload a copy of the front and back of your current health insurance card, and to answer a few questions about your insurance plan and benefits, so please have that information available before you get started.
- Once you have completed all of the fields on all screens, you will receive an immediate message from Wellfleet. Please retain this information and respond to Wellfleet if additional information is needed.

**The health insurance waiver must be completed prior to arriving on campus and no later than August 1, 2023 and for New Spring Students, the waiver deadline is January 1, 2024.**

The Certificate does not cover Loss nor provide benefits for any of the following, except as otherwise provided by the benefits of the Certificate and as shown in the Schedule of Benefits.

### General Exclusions

- **International Students Only** - Eligible expenses within Your Home Country or country of origin that would be payable or medical Treatment that is available under any governmental or national health plan for which You could be eligible.
- Treatment, service or supply which is not Medically Necessary for the diagnosis, care or Treatment of the Sickness or Injury involved. This applies even if they are prescribed, recommended or approved by Your attending Physician or dentist.
- Medical services rendered by a provider employed for or contracted with the Policyholder, including team Physicians or trainers, except as specifically provided in the Schedule of Benefits.
- Professional services rendered by an Immediate Family Member or anyone who lives with You.
- Charges of an institution, health service or infirmary for whose services payment is not required in the absence of insurance or services covered by Student Health Fees.
