Am I Eligible?

Domestic Students

All full-time Domestic graduate students are eligible for coverage under the Plan. Eligible Students can enroll in this Student Health Insurance Plan on a voluntary basis. Visit www.wellfleetstudent.com for enrollment information.

International and IEI Students

All F-1 and J-1 International students and Intensive English for International (IEI) students are required to have health insurance coverage. Eligible students will be automatically enrolled in the Student Health Insurance Plan at registration, and the Premium will be added to the student's bursar account unless proof of comparable coverage is provided by completing the waiver.*

***New International Students may not waive with a non-ACA plan.**
