## General Information

### Am I Eligible

All registered students taking 9 or more credit hours are required to take action to either

1. Enroll in the Student Health Insurance, or
2. Waive the coverage by showing proof of other medical insurance by completing the online waiver form by the deadline.

### Dependents

Dependents are not eligible.

## Plan Benefits
